After type approval, if there are changes to the design, materials used or manufacturing method of the product and important components and such changes affect major characteristics and properties of the product, or property indexes of the product are changed and exceed the scope of approval, related drawings and documents are to be examined and approved by the concerned survey office. Where deemed necessary by the survey office, the surveyor to the Society will go to witness relevant tests and conduct inspection and the results should be able to demonstrate compliance with the approval conditions.

认可后的产品检验方式/ Method of product inspection after works approval

认可后检验方式定为: 不定期检验。由工厂提交产品的检验、试验记录和报告, 本社检验人员审核, 认为结果满意后颁发产品证书或签署等效证明文件, 并由工厂在本社授权下在合格的相关产品上使用本社检验标志。除上述发证程序外, 本社检验人员可在认为必要时到工厂对产品进行检验。

The method of Irregular Inspection is used for products after works approval. Upon completion or prior to the delivery of each piece or batch of products, the manufacturer is to provide the Local Survey Unit of CCS with the inspection and test reports (records). After satisfactory review, the surveyor is to issue product certificate.

In addition, the surveyor may visit the manufacturer to inspect the products when necessary.

Note:

1, This certificate no. GB05T00003_03 replaces certificate no. HBT01430032-5.

2, Label shows expiry date on battery, and the Tron 45S battery is capable of operation more than 24Hr, the Tron 45SX battery is capable of operation more than 48Hr.

3, The products are to be mounted in manual release bracket, and them comply with annex 1 of IMO A.810(19) except clause 2.2, so no GMDSS equipments.
